## CALL FOR A LONG LIST OF EXPERTS

### Rationale

"La Clinica dei Paesi" is the **first experimental centre** conceived as a hospital for the "care" of our villages and marginal areas, with special attention to those in the inner areas, whose long existence is similar to that of someone who has lived so long and whose quality of life is undermined today.

Just as one does not abandon an elderly person, one does not abandon an old village. "La Clinica dei Paesi" was born as a response to this seemingly unstoppable trend, born as an attempt to care for those who are seriously "sick".

We run the risk that our villages - which have a history of thousands of years - will be wiped off the geographical map in a few years.

The purpose of the clinic is to "cure" them.

### ART. 1 Object

The Clinic wants to respond to the illnesses of small towns with creative proposals, to support Public Administrations operating in increasingly difficult contexts and with fewer and fewer human and economic resources, to realize the possibilities of a return to life, to re-signify "abandoned" spaces in our villages but not only, with the awareness that they are "sick," with more or less serious problems.

We are looking for **qualified and motivated professionals** to collaborate with us in different fields (social innovation, urban regeneration, performing arts, social design, etc.).

## **ART. 3 Participation requirements**

- c) not having been convicted of any criminal offense and not being the subject of any measure concerning the application of preventive measures, civil decisions and administrative measures entered in the criminal record;

- f) specific qualifications (e.g. degree, master's degree, courses) by sector;
- g) ability to work independently and in a team and flexibility for occasional collaborations.
